### Budget Billing / Equalized Payments

G.L.D.C Gas offers Equalized Billing (12 equal payments). Enrollment will be open March 16 to April 3 each year. Member accounts must be current to qualify. Each April, we reconcile payments based on your annual gas bill & actual usage. Overpayment will show a credit and underpayment will show the balance **now** owing. Equalized payment amounts are evaluated based on consumption history. Our office will call **"only if"** equalized payment amounts will be increasing

**Nomination Process**

Each member (in good standing) may nominate one candidate (in good standing) to the Board for an available position. If members are not in good standing, they will not have the right to be nominated or vote. Not more than 4 board members can be urban contract holders at the time of nomination. Neither Management nor employees can nominate a candidate, but are eligible to vote. Nomination forms must be signed by the member and nominated candidate.
